Volunteer Liability Waiver

I understand that the job(s) I have checked above, as well as any tasks related to volunteering, may be dangerous and carry with them certain inherent risks, including risks that may not be obvious, and that cannot reasonably be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks may include, and are not limited to: dangers inherent to being in confined, indoor spaces; dangers inherent in exposure to the sun for an extended period of time, or being outside during high temperatures, such as dehydration, heat stroke, and sunburns; minor injuries such as scratches, bruises, cuts, and sprains; property damage; theft; risks of contracting communicable diseases, illnesses or viruses, including, but not limited to, COVID-19 and its related variants; minor and major injuries incurred while traveling, including while traveling in a vehicle; minor damage to or theft of personal property or major damage to or theft of property, such as vehicle damage or destruction; major injuries such as emotional trauma, eye injury or loss of sight, joint or back injuries, broken bones, brain injury and concussions; catastrophic injuries, including permanent disability, paralysis, and death.

I understand that these injuries or outcomes may arise from my own actions, the actions of others, inaction or negligence, conditions related to travel, or the condition of the job or task's location. Nonetheless, I acknowledge and expressly assume all risks and dangers associated with volunteering (including travel to, from, and during my volunteer job(s) and related tasks), whether described above, known or unknown, and inherent or otherwise. I take full responsibility for any injury or loss, including death, which I may suffer, arising in whole or in part from my participation in a volunteer job and related tasks.
